TO PROSPECTIVE NEW MEMBERS:

Thank you for your interest in the Independent Electrical Contractors Association of Greater St. Louis. IEC is a professional association established to promote the highest standards in the electrical industry. It is the association in St. Louis that is directed by and for independent electrical contractors, providing a quality education and excellent training.

IEC offers two types of membership:

Contractor members are “any person, firm, partnership or corporation engaged in the business of construction, maintenance, design, or installation of electrical systems, which subscribes to the purpose of this association and is of good character and business reputation.” Contractor members must be licensed if they work in counties and cities which require licensing. All applicants for contractor membership must provide a certificate of insurance and three letters of reference to be considered for membership.

Associate members are “any person, firm, partnership or corporation engaged in a trade, industry or profession related to electrical construction which subscribes to the purpose of this association and is of good character and business reputation.”

A NEW MEMBERSHIP YEAR BEGINS OCTOBER 1ST EACH YEAR.

Following is the dues structure for the 2016/2017 Membership year. Contractor fees are billed quarterly with payments due October 1st, January 1st, April 1st, and July 1st. Upon payment of your dues, you agree to adhere to the bylaws of the association. You also agree that your company’s account will be kept current. If dues is not received by the end of the month due date, your membership status will be put on hold. If payment is not received before the next quarterly billing cycle, you will be notified of possible termination from the Association. Members will be responsible to pay any cost incurred for the collection of past due accounts.

CONTRACTOR MEMBERS: \$200.00 BASE per quarter; Plus \$50.00 for each non-apprentice field worker up to 20 per quarter; \$40.00 for the next 21 up to 60 non-apprentice field workers per quarter; \$25.00 for each IEC apprentice per quarter.

ASSOCIATE MEMBERS: \$500.00 yearly billed for payment on October 1st. This may be billed quarterly to fit your budget with due dates October 1st, January 1st, April 1st and July 1st.

IEC’s goal is to continue to represent quality independent electrical contractors. All new membership applications are reviewed by the IEC Board of Directors once a month. Membership is subject to approval by the Board. Members joining prior to or after October 1st will begin being billed the quarter following approval.
